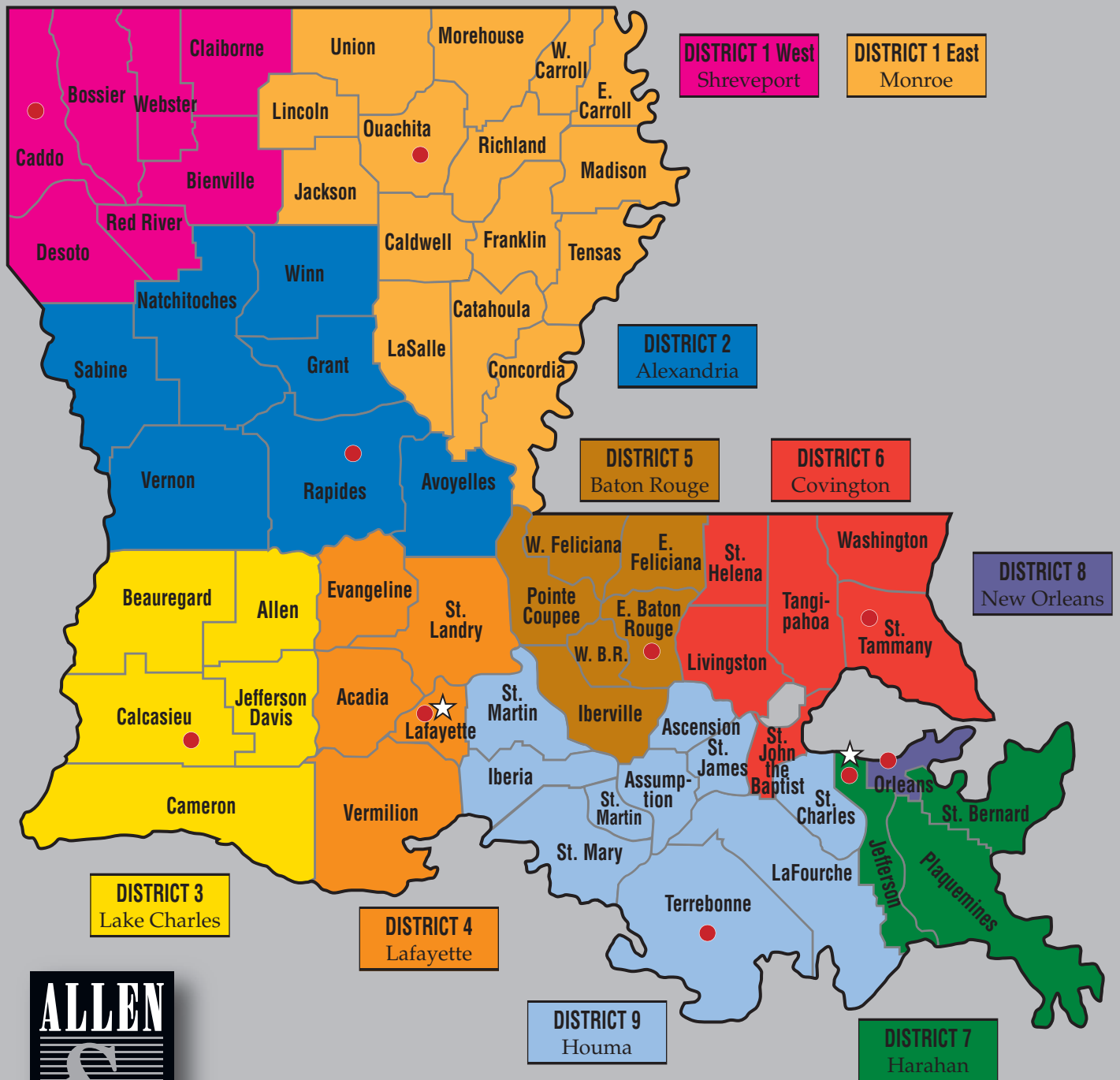

# Deadlines

## Payment of Compensation Benefits

- Temporary Total Disability Benefits - 14 Days - 1201(B)
- Supplemental Earnings Benefits - 14 Days - 1201(C)
- Permanent Total Disability Benefits - 14 Days - 1201(B)
  - Permanent Partial Benefits - 30 Days - 1201(D)

## Second Injury Fund

- Filing of Claim - 1 year from first payment of medical expense or compensation benefits - 1378(B)
  - Appeal - Within 30 Days - 1378(E)

## Reporting Guidelines

- **10 Days** - (A) WC 1007 Lost time in excess of 1 week (or death) - 1306  
(B) WC 1003 Within 10 days of SEB ending - Rule 511(B)
- **14 Days** - Final payment made of compensation benefits on WC 1003 - Rule 509(B)
- **90 Days** - OSHA Applicable employers - Complete OSHA if death, illness, injury with loss of consciousness or restriction of work or non-first aid medical treatment - Rule 1292

## Pleadings

- Answer - 15 Days - Rule 12
  - Appeal - 1310.5(B)
- (A) Suspensive Appeal - 30 Days
- (B) Devolutive Appeal - 60 Days
- Acceleration of Judgement - 6 successive installments not made - 1333

# Calculations

- SEB - 1221(3) - 90% Threshold  
Pre-Accident AMW  
less  
Post-Accident AMW

$$\frac{\quad}{66 \frac{2}{3}\%} \times \text{Result} = \text{Monthly SEB}$$

- Permanent Partial Benefits - Medically determined percentage of disability - 1221(4)

| September 1, 2020 - August 31, 2021 | \$705.00 | \$188.00 |
